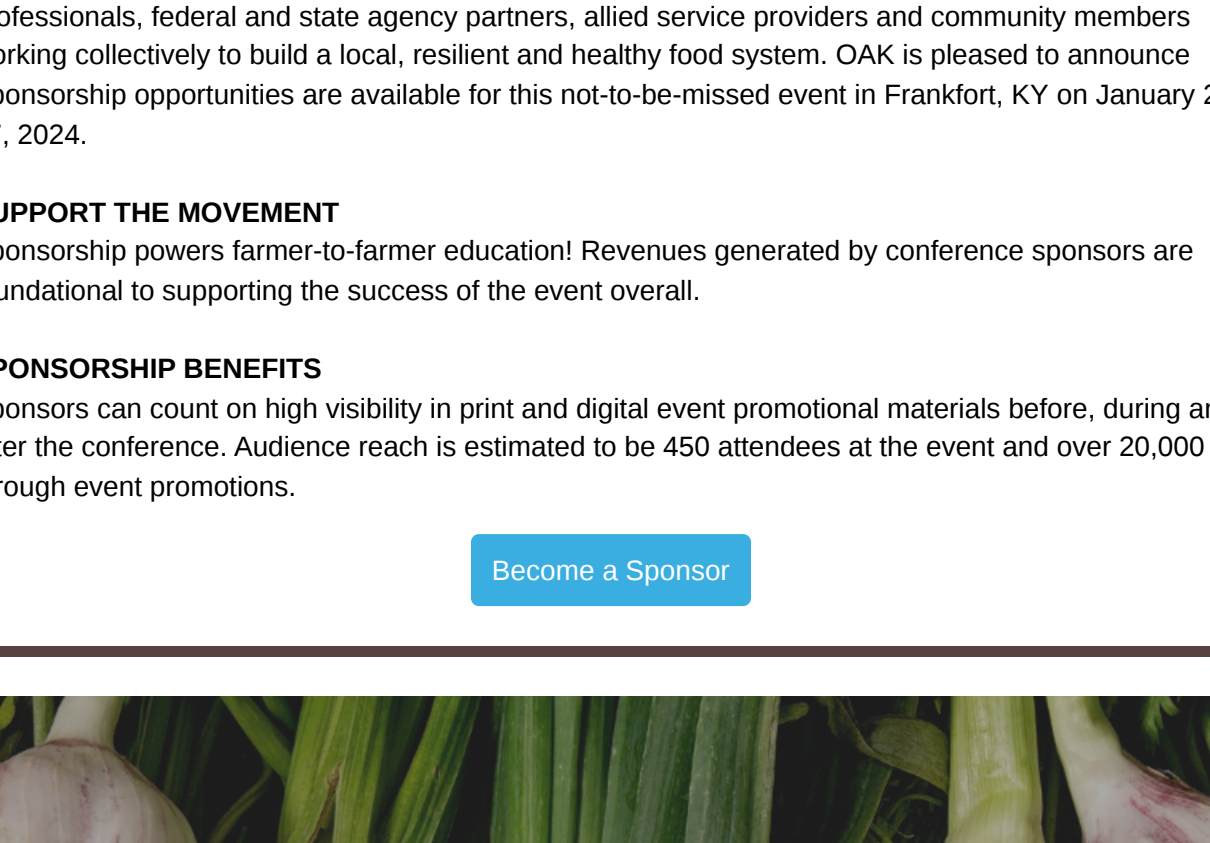

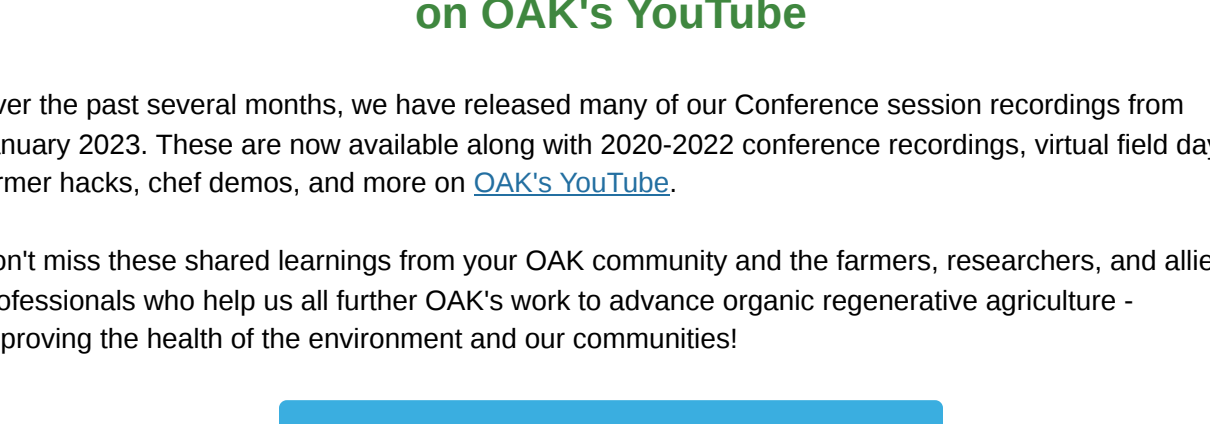

**Global Farm Metric - Farm Sustainability Assessment Tool:
Opportunities to Participate this Fall**

Do you grow specialty crops on your farm? Are you interested in soil health and whole farm sustainability? If you answered "YES" to both of these then consider joining fellow OAK member farmers this fall to trial the Global Farm Metric - Farm Sustainability Assessment Tool.

Organic Association of Kentucky (OAK) is the first international partner of a United Kingdom-based nonprofit, The Sustainable Food Trust (SFT), to trial a unique tool that measures sustainability across a farm's operation. The tool is based on SFT's [Global Farm Metric framework](#), which can be used to understand, measure and monitor the state of farming systems anywhere in the world! Kentucky's agricultural landscapes and highly diversified farms create an excellent setting to test this tool and provide farmers with a powerful story about their farm's sustainability from a holistic point of view.

OAK staff have undertaken an effort to adapt the Global Farm Metric specifically for use on Kentucky farms. The resulting first draft of the Global Farm Metric Farm Sustainability Assessment Tool (GFM-FSAT) is based on guidance from SFT, farmer input, expert advice, peer-reviewed literature, published agricultural benchmarks and best practice standards. Agricultural terms and measurement units have also been adapted to those most commonly used in Kentucky.

If you are interested to participate in the Farm Trials this fall and use the GFM-FSAT on your farm, email to studies@oak-ky.org. OAK is seeking farms that produce specialty crops for Fall 2023 (specialty crops include fruits and tree nuts, vegetables, culinary herbs and spices, medicinal plants, as well as nursery, floriculture, and horticulture crops). Farms do not need to be certified organic to take part. Participating farmers will receive an honorarium for completing the GFM-FSAT thanks to funding from the Owsley Brown II Family Foundation and a USDA Specialty Crop Block Grant administered through the Kentucky Department of Agriculture.

Not-To-Miss Opportunities and Updates

Apply for Conservation Technical and Financial Assistance with NRCS

Conservation Technical Assistance (CTA) provides farmers, ranchers and forestland owners with the knowledge and tools they need to conserve, maintain and restore the natural resources on their lands and improve the health of their operations for the future. NRCS offers this assistance at no cost to the producers they serve. Their goal is to give customers personalized advice and information, based on the latest science and research, to help them make informed decisions.

If a producer chooses to take the next step towards improving their operations, NRCS can work with them to develop a [conservation plan](#), with suggested conservation practices that can help them reach their production and conservation goals. Producers can also choose to apply for [financial assistance](#) to get help installing the conservation practices outlined in their conservation plan.

RAE Reminds Farmers: The federal 2024 fiscal year begins Oct. 1, 2023, and **all farmers should initially assume October 1st as the application deadline for receiving NRCS cost-share assistance in calendar year 2024.**

**USDA Farm Loan Borrowers Who Have Faced Discrimination:
Financial Assistance Application Process Now Open!
Attend a September Workshop to Learn More**

The application period for the U.S. Department of Agriculture's Discrimination Financial Assistance Program (DFAP) is open through **October 31, 2023**. Farmers, ranchers, and forest landowners are eligible to apply if they encountered discrimination by USDA in its farm loan programs before January 1, 2021, and/or currently hold assigned or assumed USDA farm loan debt that was subject to discrimination prior to January 1, 2021. Applications for this program are **free**, and **do not require a lawyer**. All applications that are received by the deadline will be reviewed.

The Inflation Reduction Act (IRA) specifies this assistance must be delivered to impacted producers by non-governmental program administrators. In May, USDA signed contracts with three vendors who, together, constitute a national administrator and four regional hubs. The vendors are working together to solicit applications from eligible farmers, provide technical assistance, and make decisions about each case following rules set by USDA. Serving producers in the eastern regions of the U.S., the Windsor Group LLC, will provide support to eligible farmers who may apply for the Program.

Anyone interested in applying or finding out more can visit the Windsor Group office at 107 W Loudon Ave., Ste 101, Lexington, KY between 9 a.m. - 5 p.m. ET, Monday - Friday (except for Federal holidays).

Producers who also have the option to file applications online at 22007amby.gov, by mail, or by turning in applications at the brick-and-mortar offices. The program call center number is 1-800-721-0970. Section 22007 of the Inflation Reduction Act (IRA) provides \$2.2 billion in financial assistance for farmers, ranchers, and forest landowners who experienced discrimination in USDA's farm lending programs prior to January 1, 2021. Distribution of these funds is one step in the long march towards justice and an inclusive, equitable USDA.

Grow Appalachia partners with non-profit organizations throughout central Appalachia to administer a Grow Appalachia gardening program at the local level—delivering organic production resources and technical assistance through a hired partner site coordinator so that families truly have all they need to grow their own food.

From Organic Farmers Association (OFA): Take Action Now: Urge Your Senators to Protect Organic Livestock and Poultry Standards

After years of work, a harmful amendment has been introduced in the U.S. Senate attempting to block finalization and implementation of the Organic Livestock and Poultry Standards (OLPS) Proposed Rule. The rule, which aims to update organic standards with critical animal welfare provisions, is currently in the final stage of approval. The proposed Rule encompasses decades of widespread organic community debate and industry support.

Revised Guide to USDA Discrimination Financial Assistance Program Released

Study Identifies Effective Ways to Cut Greenhouse Gas Emissions from Agriculture
From [ATRRA](#): A study by Cornell University scientists showed that [improving agricultural technologies and management techniques](#) could contribute significantly to sector-wide negative emissions. According to this study, the most effective ways to reduce emissions are to utilize soil modifications for crops (biochar, compost, and rock amendments), develop agroforestry, advance sustainable seed/ot harvesting practices, and promote hydrogen-powered fertilizer production.
